



APPLICATION FOR A SCREENING LICENSE

It serves as a great encouragement to us here at Kerugma Productions when we learn that people want to show one of our products to others. However, in order to do that one must be careful to comply with the law. The fact is that there are certain laws governing the public screening of media, such as films and DVDs. These laws are applicable for the screening to any audience, other than a private family gathering.

WHY ONE NEEDS TO HAVE A LICENSE

Various countries have different laws governing the distribution and screening of media, such as films and DVDs, and many of them are similar. This article concerns the situation in specifically South Africa. Many are not aware of the fact that before one can publicly distribute a DVD, it has to be submitted to the Film and Publication Board for their classification. After a committee of the Board has watched the production it will classify it for distribution with the necessary age restriction, etc. and that it is licensed to be used **"for home use only."** Any public viewing thereof without the necessary license would be illegal and thus prosecutable under the law. We understand that this classification is intended to protect the producers and distributors against exploitation. This law of course also protects ministries such as ours from being exploited by well meaning, but often ignorant people.

However, in order for you to be able to do a public screening of any of our products or the products that we distribute on behalf of others, we would like to issue you with the necessary license. All we ask is that you complete the attached form, e-mail or fax it to us and print it as your proof that we have issued you with the necessary license for the screening event that you are planning.

Before you complete this form, we would like to make use of the opportunity to share something about the origin of the product that you want to share with others. The cost for the filming, editing and marketing of these DVDs is often more than what the average person may anticipate. Although the acceptance of the gift of eternal life is free, it may cost those who bring the gospel message, even their lives. So it is at very high costs that these products are being made available; even at high personal sacrifices by



children of the Lord. They are doing it, trusting that the Lord will bless the distribution of these DVDs, so that many thousands will be eternally blessed by the message thereof. Therefore they are trusting that the Lord who urged them to produce these DVDs, will also work in the hearts of many Christians to contribute towards enabling others to be able to see it. They are therefore dependant on the Lord to work in the hearts of His children to contribute towards the ministry in any possible way. The initial production costs of the DVD that you want to screen may not even yet be paid by the children of the Lord who produced it and are carrying the burden of it all. However, the intention of these DVDs is to spread the Gospel message, therefore the way to recoup the necessary funds differs from the means the world would use with their products. Thus we want to urge you to show this DVD to whomever you can, but whenever you would, charge for doing so or take up an offering; we would like you to also give a fair portion of the raised income towards this ministry to enable us to continue with this work. But most importantly, please pray for us personally as well as for the financial needs of this ministry. We are daily in need of the Lord's provision, strength and wisdom in order to continue. Please keep us in your prayers as you continue with the part of the work that the Lord is leading you to do. We will pray for you and the event where you plan to screen the DVD as we receive your application form. May the Lord Jesus be with you as you help spreading His Word.
